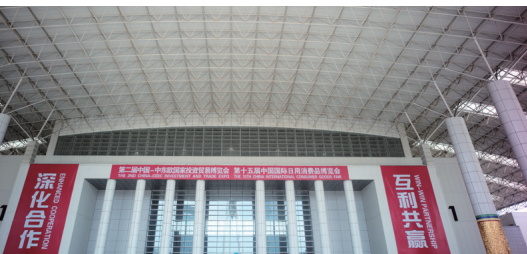
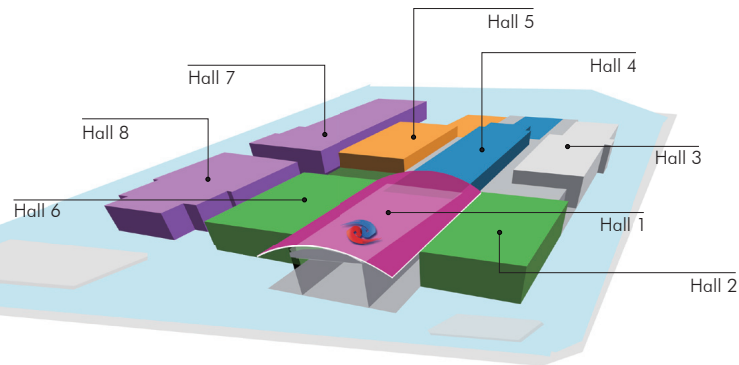


Exhibit Categories
